

Residency Form - Non-Citizen



Eligible non-citizen students may apply for in-state resident tuition if the student graduated from a high school or homeschool in Arizona **and** attended a high school/homeschool in Arizona for a minimum of two years **or** earned a high school equivalency diploma (GED) while living in Arizona for two years.

If the high school/homeschool or high school equivalency diploma (GED) was completed more than one year ago, the student must **also** have lived in Arizona for a minimum of one year immediately preceding the semester for which they are seeking in-state resident tuition.

Students are responsible for registering under the proper residency classification. This form should be submitted prior to the first day of the semester. **Forms without supporting documents will not be processed. Please refer to the list of supporting documents on page 2.**
