## THIRD AMENDMENT TO EDUCATION AFFILIATION AGREEMENT

(Banner Health Contract Number 0101-02-46723 A3)

THIS THIRD AMENDMENT TO EDUCATION AFFILIATION AGREEMENT (the "Amendment") is made and entered into as of the signature dates set forth below (the "Effective Date"), by and between Pima County Community College District (the "College/School/University"), a political subdivision of the state of Arizona, and Banner Health, an Arizona nonprofit corporation, on behalf of itself and as agent for its consolidated affiliates (collectively "BH"), each a party and collectively the parties.

WHEREAS, College/School/University and BH are parties to that certain Education Affiliation Agreement to provide student experiences at BH and BH affiliated facilities in all healthcare-related programs, including Surgical Technology program, as further described therein, dated effective April 14, 2015, as further amended by that certain First Amendment to Education Affiliation Agreement dated effective July 5, 2016, and as amended by that certain Second Amendment to Education Affiliation Agreement dated effective April 14, 2018 (collectively, the "Agreement"); and

The parties have agreed to modify certain provisions of the Agreement; and

The parties desire to evidence this modification by execution of this Amendment.

NOW, THEREFORE, the parties hereto agree as follows:

1. <u>Amendment of Agreement</u>. The parties agree to supersede paragraph 6 of the Recitals, in its entirety, and replace with the following:

THIS AGREEMENT IS DATED TO BE EFFECTIVE **UPON THE LAST SIGNATURE DATE HERETO** AND SHALL REMAIN IN EFFECT UNTIL THREE YEARS FROM THE EFFECTIVE DATE (**term shall not exceed three (3) years)**; however, either party may terminate this Agreement, with or without cause, by giving at least ninety (90) days written notice to the other party. Reasonable effort will be made to provide notice that shall not take effect during a clinical experience ("Rotation"), expect for extraordinary reasons. In the event of a material breach of any provision of this Agreement, the aggrieved party may terminate this Agreement immediately upon written notice to the other party.

- 2. <u>Agreement Effective</u>. Except as otherwise expressly provided herein, the Agreement shall remain unmodified and in full force and effect.
- 3. <u>Precedence of Amendment</u>. In the event of a conflict between the terms and conditions of this Amendment and the terms and conditions of the Agreement, the terms and conditions of this Amendment shall govern and control.
- 4. <u>Capitalized Terms</u>. All capitalized terms used in this Amendment and not otherwise defined herein shall have the meaning ascribed to such terms in the Agreement.
- 5. Incorporation. This Amendment shall be attached to, and made a part of, the Agreement.
- 6. <u>Counterparts</u>. This Amendment may be executed in one (1) or more copies or counterparts, each of which when signed shall be an original, but all of which together shall constitute one (1) instrument. Signatures submitted via telecopy or electronic signature shall have the same force and effect as original signatures and, as such, shall be valid and binding upon the parties hereto.
