# **Summary of Student Enrollment for Fiscal Year 2021-2022**

This report summarizes enrollment of Fiscal Year 2021-2022 (FY 2022), which ran from July 1, 2021 through June 30, 2022, in terms of: (i) unduplicated head count, and (ii) annual unofficial full-time student equivalent count (FTSE) generated by enrollment in credit classes and completion of select non-credit educational programs.

- (i) Annual unduplicated head count is the number of unique students served within the year. Thus, district-wide, a student is counted only once regardless of the number of campuses attended or courses enrolled. Within a campus, a student is counted once regardless of number of courses enrolled at that campus.
- (ii) One annual unofficial Full Time Student Equivalent (FTSE) unit is equivalent to 30 credit hours of enrollment in credit courses, or 640 clock hours spent in completion in select non-credit programs. That is, every 30 credit hours of credit course enrollment at the college adds 1 to the unofficial FTSE count. Similarly, every 640 clock hours completed in select non-credit programs adds 1 to the unofficial FTSE count, those programs being:
  - a. Pima Community College Adult Education (PCCABECC or ABE)
  - b. Those courses offered by the Center for Training and Development (CTD)

In FY 2022, the College's total annual unduplicated head count was 35,241 and its total annual unofficial FTSE was 11,736.84. Total headcount increased 2,962 students (9.18%) over FY 2021. The most significant changes by term were the increases in Non Credit (+52%) and Adult Education (+106%) in FY 2022 compared to FY 2021.

  - 3.1. *Hybrid:* Students receive instruction online and in the classroom with reduced time.
  - 3.2. *In Person:* Students are required to attend lecture and/or lab on specified days and times.
  - 3.3. Online: Students complete class activities online and may have flexible meeting times.
  - 3.4. *Virtual:* Students attend live online meetings on specified days and times and complete additional work independently.
  - 3.5. Other Modalities
    - 3.5.1. Self Paced In Person: Students work on-campus each week at their own pace, in the room defined in the class schedule, with faculty guidance.
    - 3.5.2. Self Paced Independent: Students work off-campus at their own pace, with study materials prepared by College faculty.

The greatest changes in instructional method were the increases in Hybrid (headcount +123%) and In Person (headcount +197%) modalities, as Pima continues to recover from the effects of the Corona Virus pandemic.

In FY 2022, the College's total annual unofficial FTSE was 11,736.84. Total unofficial FTSE decreased by -135 (-1 %) from FY2021. As Non Credit and Adult Education terms (see Table 1a) are not reflected in unofficial FTSE, the greatest change was the increase in the Full Year Credit Term (+25%).
