Position Title: Vice President of Distance Education

Job Group: Executive Administration

Job Level Group: Deputy Administrator

FLSA Status: Exempt

Position Summary:

The Vice President of Distance Education provides leadership for the planning, development, and delivery of distance learning programs and courses. Areas of oversight include: Dean of Distance Ed. (Faculty online dept. heads, online quality, and instructional design). Dir. of LMS Services (D2l Brightspace), Online Student Success, and PimaOnline Partnerships.

Essential Duties and Responsibilities:

Examples of key duties are interpreted as being descriptive and not restrictive in nature. Incumbents routinely perform approximately 80% of the duties below.

- 1. Develop and implement short and long-range strategic plans to advance the College's mission in distance learning that supports and expands the online learning enrollment regionally and out of state.
- 2. Ensure a unified approach to high-quality standards in the online teaching/learning environment for teaching, course development, and the use of innovative educational technology
- Manage and direct the activities of the Distance Education department
- 4. Provides leadership for accreditation, accessibility, and other eLearning-related considerations
- 5. Oversee budgeting, accounting and financial reporting activities for assigned department.
- 6. Participate as an active and contributing member of a team to achieve goals
- 7. Ensure compliance with College policies and state and federal laws that training and development requirements.
- 8. Maintain effective partnerships with staff and administrators to reach departmental goals.
- 9. Supervise employees, including prioritizing and assigning work
- **10.** Identifies and assesses current and future organizational development needs through process analysis and collaboration with senior management to meet College objectives
- **11.** Oversee employee hiring, corrective action, disciplinary and termination recommendations as necessary
- **12.** Direct and supervise the collection and review of data and the preparation of a variety of reports, statements, and communications
- **13.** Participate in special studies and recommending improvements to department practices, policies and processes.

- **14.** Develop appropriate metrics and tracking mechanisms to measure overall department effectiveness and individual programs
- 15. Collaborates with other departments as necessary in order to meet college objectives and goals.
- **16.** Performs all other duties and responsibilities as assigned or directed by the supervisor.

Knowledge, Skills, and Abilities:

- 1. Knowledge of regulatory compliance principles and practices.
- 2. Skill in people leadership and supervision.
- 3. Skill in effective communication (both written and oral).
- 4. Skill in independent decision making.
- 5. Skill in positive productive, and flexible customer service.
- 6. Skill in budget/resource management.
- 7. Ability to develop and maintain effective and positive working relationships.
- 8. Ability to apply analytical and critical thinking skills as well as draw conclusions and prepare accurate reports of results.

Supervision:

• Executive Level Leadership. Supervises work of other managers, including planning and reviewing work.

Independence of Action:

 Results are defined; employee sets own goals and determines how to accomplish results with few or no guidelines to follow, although precedents may exist; supervisor/manager provides broad guidance and overall direction.

Competencies:

Competencies are the actions and behaviors that can be observed as to how work gets done that supports the College's values and strategic objectives.

- Organizational Culture: Provides an opportunity to impact the organizational culture of Pima Community College by both acknowledging the College's past and helping to chart its future.
- Governance, Institutional Policy, and Legislation: Allows impact on the guidelines that determine how the College operates..

- Institutional Leadership: Provides the opportunity to provide leadership across the institution. Leading by example and supporting team building.
- Information and Analytics: Allows ability to be a data leader. Provides a holistic representation of College's performance as well as data trends or issues.

Minimum Qualifications:

Candidates/incumbents must meet the minimum qualifications as detailed below.

- · Master's degree in related field required
- Ten (10) years of related experience required
- Six plus (6+) years of related experience with supervisory experience preferred.

OR An equivalent combination of certification, education and experience sufficient to successfully perform the essential duties of the job such as those listed above

Physical Demands:

- **Environment:** Work is performed primarily in a standard office environment with staff contact and frequent interruptions.
